

**Shop to Win an eBike – Trade Promotion Terms & Conditions****1. Promoter**

The promoter is Beijer Ref Holdings Australia Pty Ltd (ABN 28 607 082 379) of 2 Kirby Place, Bankstown Aerodrome NSW 2200 ("Promoter").

**2. Promotion Period**

The promotion commences at 10:00am AEST on 5 May 2026 and closes at 5:00pm AEST on 8 May 2026 ("Promotion Period").

**3. Eligibility**
